Below are today's notes from the Governor's daily press conference. Two other developments are the creation of the Ohio House 2020 Economic Recovery Task Force and the Ohio tax receipts.

According to the Office of Budget and Management, the state tax receipts in March were down \$159.4 million, or 10% from at the analysts projected. The DeWine Administration has already instructed agencies to freeze new contracts and identify cuts of up to 20%.

Speaker Householder announced the 2020 Economic Recovery Task Force, consisting of a 24member panel and will be chaired by Rep. Paul Zeltwanger, and Rep. Terrence Unchurch as vice chair.

Governor Mike DeWine

- Today the Governor wore a Kent State tie

- Snap eligible households can soon pick up a pre-packaged box of food at their local food bank. This took a federal waiver.
- ODJFS announced that for those who did not already receive the maximum month allotment that they would be issued an additional payment beginning this week
- Liquor Control Commission passed an emergency rule to allow establishment with an existing on-premises liquor permit to sell and deliver alcohol—including high-proof liquor in

limited quality, for off-premises consumption (under the rule, patrons can purchase two, prepackaged drinks per meal. All drinks must be closed and remain closed during transport as per open container law)

- Spoke to the prison staff and the importance of taking care of their health and well being. Prison numbers are on the decline.
- Governor made pitch for inmates to have early release, under certain conditions and for judges and prosecutors to waive the 60 days notice so they can take them directly to the parole board. Governor said there is a group of 26 inmates statewide that are 60+ or older who have one or more chronic health conditions. There is a group of 141 inmates who qualify for emergency release under Ohio's Overcrowding Emergency statute. These are inmates that live in "open bays" with 80-300 people and sleep in close conditions. The potential for fast spread is greater. Ohio Revised Code allows the Director of Rehabilitations and Corrections authority to release inmates with coordination with the Ohio Parole Board in case of an emergency (90 days or less of the date of release). When determining who would be on the lists for early release the Governor said that they narrowed list down and removed sex offenders, homocide, kidnapping and obduction, ethnic intimidation, domestic violence, and those who have been denied in the past for judicial relief.

Lt. Governor Jon Husted
