

#### **Selection Criteria**

The Ohio AgriBusiness Association will select no more than 25 promising leaders in the agribusiness community to participate in the 2017 Leaders Achieving New Career Heights, or LAUNCH, program. The participants will be chosen by OABA's selection committee through an application review process.

## **Program Outline**

The LAUNCH program will consist of:

- two sessions (three days each)
- webinars
- networking opportunities
- and a capstone project

By committing to the program, participants are expected to attend all sessions on the dates noted below, complete the capstone project and make every effort to participate in scheduled webinars and the networking opportunities.

#### Session Dates:

- 1. January 10-12 Columbus area
- 2. February 21-23 Cincinnati area

The program topics and skills practiced include: personal insight, executive leadership skills and decision making including strategic planning, critical thinking, change management, goal setting and organizational skills; communication and presentation skills; global issues in agriculture; sales and marketing principles; Ohio/regional trends in agribusiness; state and local government; how to develop a successful mentor-mentee relationship; and a capstone project.

## Requirements/Application Process

Registration for this event is different than most OABA training opportunities. Those interested in participating in the process will need to go through the following short application process:

- 1. Applicants must work for a member organization/company of the Ohio AgriBusiness Association.
- 2. Aspiring leaders will need to talk with their supervisor and/or company leadership to determine if the interested individual has approval to commit to the program.
- 3. Individuals must fully complete an official application, which includes a letter of recommendation.
- 4. Applicants and their supervisors and/or company leadership must sign a letter of commitment to the two sessions.
